







I am a teacher. I can comfort children. Sing songs. Read books. Make art. I can also serve food and clean


I am an ARNP. First Second Third Aid, Triage, Organization, Communication, Comforting skills. I went to a medical disaster training in AL. It was several years ago.

Material and inventory management. "Stuff" allocation and distribution.


Q8 - 7. Should FHPC establish an Emergency Response Network to communicate with and assist Church members impacted by power outages or other short-term emergency situations?


Q9 - 8. Should FHPC assist with short-term housing for local disaster victims?


Q10 - 9. Should FHPC assist with short-term housing for non-local victims temporarily displaced?


Q11 - 10. Should FHPC coordinate assistance programs with other churches in the community?


Q12 - 11. Should FHPC explore options for short-terms stays for volunteers who come to the Clemson area to assist with disaster relief?





For trips such as PDA Teams, congregants who serve would most likely need to take PTO from work. From my experience with PDA, often they will not know the exact type of work needed from a team until a week or so before a trip so folks need to be flexible about need. For example, you may have people who want to do construction, but the actual need for work may be clean up or destruction depending on timing. PDA has great resource people to help churches determine how to help and if facilities meet requirements. I do not think FHPC's would meet the norms for an emergency shelter, but in terms of local support, set up like Family Promise, that may be doable for short-term needs.

Sorry doing this from an iphone; question ? #11? i could keep someone short term in my home but not for months and months. I'd like to see us succeed in what we do and not bite off more than we can do. I believe that we can start with a text blast etc for congregational needs/emergencies. Assess our facilities for housing memberships and local people during times of emergencies. I'd like to see us house relief workers enroute to disaster locations. i believe we can do these with a small core of committed people.

Because of our basement collapse, we have some knowledge and some supplies. We found that having able-bodied helpers was important, as well as someone to coordinate everyone's efforts. The food train that was established was a greater support than we could have imagined. In case of local disaster/emergency relief, we have some camping equipment for short-term housing. We have a chain saw and trucks capable of hauling. We have electrical and plumbing knowledge such that we could provide extra hands under the supervision of a licensed professional.

We have the non-medical mission teams going to Guatemala and Water Missions in Charleston, SC. A program of disaster assistance in the Carolinas would be a welcome addition and a way to extend the disciples of Christ movement.

The church should not try to replace what the PDA does on a national scale as they have more experience in dealing with disasters.

My age, 80, will be a factor in what I can and cannot do to be helpful, plus I am now living in Easley.

With prayer I answered yes to several of these questions, but really I do not know because we travel a lot. I do not want to sign up for something and then not be here when needed.

Care for members through a network- built in system though our deacons

FHPC should be involved in disaster/emergency assistance. I think we can and should arrange for a work group with some members having received PDA/Red Cross training that would be on call for disaster relief assistance. We should arrange to host local families impacted by emergencies/disasters. A communication network should be established to address local power outages, flooding or other events that affect FHPC families.

Due to lack of facilities at our church, I think we need to be practical about what we can do. Each church has unique talents and limitations. For example, I am aware that the Presbetry is no longer giving support to our campus ministry program. Perhaps that needs to be our focus as our local outreach ministry, in which case we would commit to fully fund this ministry out of our annual budget in lieu of more support to some of these other programs.

There are so many wonderful support networks already in place. Encourage support through existing networks and where members already have connections and are actively reaching out into the community. Coordinate to help make existing support infrastructure more effective. If a specific gap is identified in the process, then consider FHPC leadership and development on a case by case basis.

I believe it is important to help those in need. The recent disasters are devastating. I will be honest and say it is very difficult for me to get away because I juggle 4 children and full time work in a daily basis. I am always willing to try. I can contribute food and money most easily. I do believe our church should open its arms and facilities whenever we can.

I think I would be glad to work with the church on any local disasters, I'm not sure how willing I am to go to other disasters to assist. If we had a response list, saying what others will pull to do, that would be a very useful list. We have an extra bedroom that could be used. I can also cook a meal if need be. I have no medical expertise, nor am I physically able to pull folks from a flood.

Not entirely sure the task force for power outages, etc for members is necessary...but not entirely sure it's not. Is that something we could coordinate through deacon groups?
